What is it?

- The General Data Protection Regulation (GDPR) replaces the Data Protection Directive 95/46/EC
- The GDPR (Regulation (EU) 2016/679) is Europe's new framework for data protection. GDPR was adopted by both the European Parliament and the European Council in April 2016.

Why are the current data protection rules changing?

- The data Protection Directive is outdated and doesn't meet the needs of the twenty-first century.
- The primary objectives of the GDPR are to give citizens back the control of their personal data and to simplify the regulatory environment for international business by unifying the regulation within the EU.

When is it happening?

- 25th May 2018. The Government has confirmed that the decision to leave the EU will not affect the commencement of GDPR.

Who does it apply to?

- GDPR applies to EU and non-EU companies offering products/services within the European market, or if they collect/process data on European customers.

What happens if a company doesn't comply with GDPR?

- If the GDPR law is broken, and depending on the severity of the breach, a company can be fined up to 4% of their global revenues or €20 million; whichever is greater.

Who will enforce GDPR in the UK?

- The Information Commissioner's Office (ICO)
