### **Payment Services Regulations 2017 - Intermediaries**

Thanks to AIME's continuous lobbying of HM Treasury and FCA supported by PSA and MobileUK, the PSD2 Telecom Operators Exclusion clause was re-written to ensure that intermediaries, enabling the excluded payment services for both mobile and fixed line services also benefitted from the exclusion and were not subject to separate Financial regulation as Payment Acquirers.

AIME continues to work on behalf of Mobile and Fixed Operators to reduce the impact of the limits applied by the exclusion.

### **General Data Protection Regulation Seminar**

The network exclusion from payment services regulations is assumed to encompass premium rate voice, premium rate text and charge to bill payments, but AIME uncovered information authored in Europe that potentially redefines the scope of voice and text services in relation to the PSR's. AIME is seeking legal advice to take this development forward.
