

# Vacancies Board Application and posting guide

If you wish to advertise a vacancy within your company you can now do this with aimm! We will post your job advertisement on our **Vacancies Board** and also promote your vacancy through our social media channels. Once your application is complete we will add your submission to the vacancies board and will link directly to the full page advertisement you provide. For further details please see the Pricing Guide below.

To submit your vacancy application you will be required to complete the **Vacancy Details Form** which can be found on the Vacancies Board, and then follow the PDF guidelines provided.

## **PDF Advertisement Requirements**

aimm will provide a clickable link from the job vacancy post that leads to the full page PDF advertisement which you supply. This PDF gives you the opportunity to ensure that the job advertisement contains the full job spec details, and is formatted and branded in your company style.

The PDF should contain:

- Your full company name
- Your company logo
- The job title
- Job description and all requirements regarding the role (experience etc) that you wish to include
- Closing date
- Who to apply to (live links to any email address given)
- How to apply (live links to any web portals etc for candidates to apply)

Please ensure that all information provided is correct and checked before sending for posting.

Please ensure all information provided including contact information for candidates to use is correct. aimm will not be responsible for any errors at time of uploading.

aimm will not create the vacancy PDF's for employers.

**aimm** will not take any other part in the application process or have any contact with any potential applicants.

## Vacancy Board Post pricing

All vacancies posted with aimm will run for 6 weeks from the date initially posted online. You will be sent a reminder of your listing expiry date to allow you to renew if required.
