The other role will serve on the Investment Committee and Finance, Audit and Risk Committee.

ABOUT BBC CHILDREN IN NEED

BBC Children in Need is a national charity which occupies a cherished place in the hearts of the British public. Thanks to them, in the last year we helped change the lives of over 600,000 children and young people in communities right across the UK. We currently fund over 3,000 projects and activities and celebrated our 40th anniversary in 2020.

We raise money in our annual November appeal and throughout the year, which we put to work where it's needed most. We fund local charities and projects who help remove the barriers that are facing children and young people, so that they can thrive. We work closely with a whole range of organisations so we can understand where the need is greatest, ensuring the money raised goes to supporting the young people who need us most.

Every child deserves a childhood that is safe, happy and secure with the opportunity to reach their potential. We know that a growing number of children are experiencing ever increasing and more complex levels of disadvantage, exacerbated by Covid-19 in the last 12 months.

We support children and young affected by a whole range of disadvantages such as poverty, disability, illness, distress or trauma. We work with local projects and a range of partners to tackle some of the most pressing issues facing the UK's children and young people today, including: mental health and wellbeing; violence impacting young people; child sexual exploitation; holiday hunger; access to employment; and social injustice.

Across the four nations of the UK, fundraisers from all walks of life come together to support us – from marathons to cake sales, to school events and our brilliant corporate partners – every sponsor, every pair of ears bought, every pound popped in a bucket helps change lives.

BBC Children in Need is the largest of the BBC's own charities with an income last year of £85m. From epic challenges featuring famous faces alongside children we support to special programmes and our annual Appeal Show, the BBC itself and its programmes help us raise a phenomenal amount of money each year. The other BBC Charity is BBC Media Action and like BBC Children in Need is a separate organisation which is not funded by the licence fee. Other organisations, such as Comic Relief, are completely separate and do not sit within the BBC, although they are supported by the BBC.

Whilst we are part of the BBC family, we're not funded by the licence fee. Our running costs are met through Gift Aid, Investments and, from 2019/20, a small percentage (less than 5p in each £) from donations. Over 95% raised goes directly to create impact through our Impact programmes. We are a company limited by guarantee as well as a registered charity, with the BBC owning the intellectual property associated with our name and brand and granting us a licence for its use. As a registered charity our primary regulator is the Charity Commission for England and Wales. We own a small trading subsidiary, BBC Children in Need Limited.

ABOUT THE BOARD OF TRUSTEES

The Board of Trustees is the governing body of BBC Children in Need and is ultimately responsible for everything the charitable company does. The Board of Trustees act together as a group (rather than as individuals) to further the charitable objects of the organisation. Trustees are the legal Directors of the organisation.

In line with its governing document, the charity can have up to 13 Trustees. The BBC is the 'Founder member' of BBC Children in Need, and as such is entitled to appoint a Director/Trustee, known as the 'Founders Trustee'. Half of the remaining Trustees (up to 6) are recruited and appointed because of a connection with the BBC, with the remainder recruited and appointed from outside of the BBC.

Our current Trustees come from a wide range of backgrounds and bring a range of skills and experiences – short biographies can be found on the **website**.

New Trustees are appointed by the existing members of the Board. When filling vacancies, the Board takes into account the skills, knowledge and experience needed to maintain the Board's ability to direct effectively the full range of the charity's activities.

All new Trustees receive an induction to help them fully understand the nature of BBC Children in Need and its purpose, and to explain the roles and responsibilities of a new Trustee. Training and development resources are also available to support new Trustees, and develop the skills of existing Trustees. Trustees are appointed for a three year term, which can be extended by a further two, three year terms.

The Board has a small number of committees to support its work and help it fulfil its responsibilities:

- Impact Committee
- Finance, Audit and Risk Committee
- Investment Committee
- Nominations and Remuneration Committee
- BBC Children in Need Ltd Board
- (in the process of being established)
 Development Committee

Trustees are asked to join one or two committees that are best suited to their experience, knowledge and skill sets.



TRUSTEE TIME COMMITMENT

Board and Committee meetings have generally been held at Broadcasting House, London, although are currently being conducted via Zoom. Meetings take place during the normal working day.

Trustees are appointed for a three year term, which can be extended by a further two, three year terms (i.e. a maximum of nine years in total). We would expect the two Trustees appointed through this recruitment process to join the Board in summer 2021.

The time commitment includes attending five Board meetings a year (circa three hours each) plus an away day and relevant committee meetings (each committee meets, on average, four times per year), averaging out at up to a day a month.

Trustees are encouraged to see the impact of our work by visiting projects we fund.

Our Trustees are unremunerated. However travel expenses, directly incurred in the role as Trustee on official business, can be reimbursed.

TRUSTEE DUTIES AND RESPONSIBILITIES

The duties of a Trustee Board member are to:

- contribute actively to the Board of Trustees, working with the Chief Executive and Executive Team, to develop and agree strategic goals and objectives
- define the parameters on which the budget will be based, agree the budget and monitor financial performance to ensure the financial sustainability of BBC Children in Need
- monitor the charity's progress towards the achievement of its strategic goals and objectives and monitor the impact of its activities on its beneficiaries
- safeguard the good name and values of BBC Children in Need
- ensure that BBC Children in Need complies with its governing document (its Articles of Association), charity law, company law and any other relevant legislation or regulations
- ensure that BBC Children in Need uses its
 resources exclusively in pursuance of its objects:
 the charity must not spend money on activities
 which are not included in its own objects, no
 matter how worthwhile or charitable those
 activities are.
- establish and, as necessary, review a clear framework of delegation to committees and the Chief Executive and Executive Team, monitor compliance with that framework and hold Committees and the Chief Executive and Executive Team accountable for the authority that has been delegated to them
- be accountable to stakeholders for the way in which they have discharged their responsibilities as Trustees

In addition to the above, each Trustee should use any specific skills, knowledge or experience they have to help the Board of Trustees reach sound decisions and increase the impact of its activities.

This may involve leading discussions, identifying key issues, providing advice and guidance on new initiatives, and evaluating or offering advice on other areas in which the Trustee has particular expertise. It may also involve introducing and enhancing relationships with third parties whose support will help BBC Children in Need meets it ambitions.

Trustees are expected to:

- identify with, and be motivated by, the values and objectives of BBC Children in Need
- champion the work of BBC Children in Need and the need for its support/services to external audiences
- introduce and support existing fundraising initiatives
- think strategically, look for innovative solutions, provide constructive challenge and be willing to contribute
- work collaboratively with a talented Board and Executive Team to take decisions for the good of BBC Children in Need.
- demonstrate Nolan's seven principles of public life, namely: selflessness, integrity, objectivity, accountability, openness, honesty and leadership
- have a willingness to give as much time as they reasonably and productively can and at least the minimum time requirement
- understand and accept the legal duties, responsibilities and liabilities of Trusteeship

As a Trustee, your statutory responsibilities are clearly set out in the Charity Commission's publication CC3: The essential Trustee: what you need to know, what you need to do.
